Course Overview

This course will be of benefit to people working in a licensed premise. Employees who are required to stop people entering licensed premises and clubs will find this most beneficial. The course introduces the employees to their lawful rights under legislation to stop or turn out of a licensed premises a person. Security officers, employees working as a Duty Manager or front desk reception will benefit.

Entry Requirements

Applicants must be able to speak and comprehend English to an acceptable standard. Applicants will be required to give clear directions under adverse conditions during training.

Other associated costs

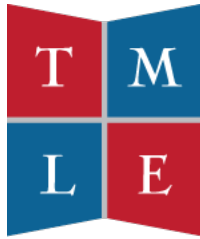
There are residential classes which participants must attend. Participants are advised any costs involved in attending any classroom instruction is not included in the course costs and is to be met by the participant.
